In consideration of your allowing me/us loans, Overdraft or other credit or accommodation or, any other form of financial assistance from time to time or at any time, I/We hereby pledge with you as security for repayment to you on demand of all amounts due or which hereafter may become due from me/us to you as well as for all interest thereon at the rate or rates that you may from time to time determine as payable thereon and all costs, charges and expenses on all shares and/or stocks with transfer forms duly signed in blank and/or securities duly endorsed in your favour which I/We now deposit or which I/We may have already deposited with you or which may be in your possession on my/our behalf and also all shares, stocks and/or securities which I/We may hereafter deposit with you in addition to or in substitution for the shares, stocks and/or securities already deposited or which may hereafter come into your possession on my/our behalf and I/We the undersigned hereby appoint you as my/our attorney for the purpose hereafter mentioned and specially authorise and empower you and all attorney holding power of attorney of your behalf to fill up and complete any incomplete transfer form attached to any of such shares and/or stock and to insert your or that of any other employee of Janata Bank Limited therein as transferee of the shares and/or stocks enumerated therein and to sign or as the case may be to sign, seal, execute and deliver any such transfer or other documents that may be necessary or required for the purpose of completing your title to any such shares, stocks and/or securities and register the same in the books of the concern to which the same relate or with the public debt office in case of securities and obtain fresh scrip or scrips for the shares stocks and/or securities enumerated herein in the name of Janata Bank Limited or in that of any other employee or nominee of Janata Bank Limited without any reference to or consent of me/us and also to pledge and/or sell and absolutely dispose of all or any such shares, stocks and/or securities at such price and in such manner as you may think fit without any reference to or consent of me/us and I/We hereby agree at your request to sign and/or endorse of as the case may be to sign, seal, execute and deliver any transfer or other document that may be necessary or required by you for the purpose of completing your title to any such shares stock and/or securities or for the purpose of completing the seal thereof. Any of my/our failing to do so I/We authorise and empower you and all attorney holding powers of attorney on your behalf to sign, seal, execute and deliver any transfer or other documents for the purpose of effecting and completing the sale in my/our name and I/We further authorise you to reimburse yourself out of the proceeds of any pledge or sale all costs, charges and expenses incurred by you in transferring and selling all or any such shares, stocks and/or securities or maintaining the value thereof or otherwise in connection therewith and I/We declare that you shall not be responsible for any loss from or through any brokers or others employed in the sale of any such shares, stocks and/or securities or for any loss or depreciation in value of any such shares, stocks and/or securities arising from or through any cause whatsoever and deficiency whatsoever and howsoever arising I/We agree to make good any payment on demand to you. And it is further agreed that you shall have a lien on all such shares, stocks and/or securities or the proceeds thereof after sale (if sold) as security for or in part payment of any other debt due or liability then incurred or likely to be incurred by me/us to you and I/We further

make good any payment on demand to you and I/We further authorise you to collect all dividends and bonus or interest as the case may be payable or hereafter paid in respect of any shares, stock and/or securities and agree to sign all such further documents as may be necessary for effectual to vest in or secure to you the property in the said shares, stocks and/or securities and dividends, bonus and interest payable in respect thereof or to effect the selling or transferring of the same or to enable you to obtain new shares, stocks and/or scrips in the event of any company being wound up or reconstituted and I/We further agree to all times to keep up the value of such shares, stocks and/or securities and in the event of a temporary or permanent depreciation in the value of any such shares, stocks and/or securities at your request either to pay to you in money the difference between the market value of any such shares, stocks and securities on the day when they were deposited with or came into your possession and on the date on which you may call upon me/us to deposit such difference or in the alternative to deposit with you further approved shares, stocks and/or securities equivalent to value to the market deterioration and I/We further expressly agree that in the event of any of the shares pledged by me/us with you being partly paid shares I/We shall immediately on a call being made pay up the amount of such call to you and my/our failure to do so, you shall, without being bound to do so, be entitled at your discretion either to pay the amount of such call and to debit the same to my/our account or to sell off such shares in the manner mentioned herein above. In the event of your paying amount of call I/We shall immediately reimburse the amount to you with interest whereon at the rate of ----- per annum till payment. And in the event of my/our failing to comply with such request of failing to pay to you on demand all or any part of the money the due/owing by me/us to you, I/We hereby authorise you to exercise all or any of the powers hereby conferred upon you and I/We declare that you shall not be answerable or responsible for any damage or depreciation which any such shares, stocks and/or securities may suffer whilst in your possession under this agreement nor shall you be under any liability whatsoever to make any payment or money or to do any other act or things for the purpose of preventing loss or depreciation in the value of the said shares, stocks, and/or securities. And I/We further declare that, I/We are the owners of all the shares, stocks and/or securities already and now or about to be deposited by me/us to you and the same are accepted for such deposit within my/our own disposition and control and free from any price charge. And I/We hereby also agree that any notice in writing required to be served herein shall be sufficiently served if addressed to me/us at my/our address registered with you or in the event of no such address being registered, at my/our last known place of residence or business and left at such address or place if forwarded to me/us by post at the address or place aforesaid. A notice sent by post shall be deemed to have been given at the time when in due course of post it would be delivered at the address to which it is sent.
